PEER MENTORING IN LONG-TERM SUPPORT SERVICES: A COLLABORATIVE PILOT IN WI

This presentation will introduce Disability Service Provider Network members to a groundbreaking Peer Mentoring Pilot developed in partnership with Includa (an MCO), the Wisconsin Board for People with Developmental Disabilities (WIBPDD), and providers ODC and Aptiv. Designed for adults receiving long-term support services, the program empowers individuals with lived experience to serve as Peer Mentors—sharing their stories, offering encouragement, and helping others build their self-advocacy skills. Attendees will learn about the development of the pilot, hear from partners involved in implementation, and explore the impact of peer-driven support on participant confidence, engagement, and outcomes.
